# Community Governance Review: Responses to the Second Stage of Consultation 19 July 2018

### **Report of Democratic Services Manager**

#### PURPOSE OF REPORT

To consider the responses received to the second stage of consultation process and agree the matters for inclusion in the Draft Reorganisation Order

#### This report is public

#### **RECOMMENDATIONS**

- (1) To consider all responses received to the second stage consultation and agree any amendments to the draft Terms of Reference, under which the Community Governance Review is to be undertaken, prior to a further period of consultation.
- (2) To decide on the method for considering any further responses to the Terms of Reference and agreement of the Draft Reorganisation Order for submission to Council in September 2018.

#### 1.0 Background

- 1.1 Council Business Committee considered the Community Governance Review (CGR) of the whole district at its meetings on 03 November 2017 and 22 February 2018. The CGR is undertaken in accordance with the provisions of the Local Government and Public Involvement in Health Act 2007.
- 1.2 The Committee agreed a timetable for the process. The second stage has now been concluded and responses are included in this report.

#### 2.0 Responses to the second stage of consultation

#### 2.1 **Proposal to create Heysham Parish Council**

17 canvassing staff were employed to visit all properties within the proposed boundary of Heysham Parish Council. Where householders were able to answer, canvassers engaged with them to establish their view on the creation of the Parish Council and any comments were recorded. These are shown at Appendix A to the report.

Written comments were also received from a number of households. These generally provided a yes or no response and have been broken down into comments for Yes at Appendix B and Comments for No at Appendix C.

Responses were very mixed, with no overall outcome seen.

# 2.2 <u>The merging of Yealand Conyers Parish Council and Yealand Redmayne</u> Parish Council into one parish to be titled "Yealand Parish Council"

A total of 12 responses were received from residents in Yealand Redmayne and Conyers and the majority were in support of merging. However, Yealand Conyers Parish Council has now indicated that, although they can see the benefit of working as a merged authority under one heading, they do not feel that the time is currently right for that to happen and would prefer status quo. They are aware of the ability to start the process again by way of a petition and are happy to revisit this in the future.

It is therefore recommended that this proposal is taken no further.

### 2.3 <u>The renaming of Thurnham Parish Council as "Glasson and Thurnham</u> Parish Council"

A total of 17 responses were received - 12 being in favour of the name change, and 5 against.

However, 4 responders in favour have suggested a variation on the change of name. "Thurnham with Glasson" has been suggested by 2 people, "Thurnham and Glasson" has been suggested by 1 person and "Thurnham Glasson" has been suggested by 1 person.

Copies of the responses received are found at Appendix D.

#### 3.0 Updated Terms of Reference

3.1 Once Council Business Committee has decided the issues to be taken further, the draft Terms of Reference can be recirculated for a short time to allow further comment. Any comments received can again be considered by members of the Council Business Committee and a Draft Reorganisation Order prepared.

#### 4.0 Draft Reorganisation Order

4.1 It is proposed that the Draft Reorganisation Order will be submitted to Council for approval in September 2018. Approval of the Order will signify the agreement by the Council to the details contained within it and will form the basis for any change to be effective from 01 April 2019.

#### 5.0 Conclusion

- 5.1 Before proposing the content of the Draft Reorganisation Order the Council Business Committee has to be clear that the wishes of the people affected by the proposals are being reflected in the outcome.
- 5.2 DCLG Guidance on Community Governance Reviews states that in making its recommendations, the review should consider the information it has

received in the form of expressions of local opinion on the matters considered by the review, representations made by local people and other interested persons, and also use its own knowledge of the local area.

5.3 The guidance also states that the aim of the 2007 Act is to open up a wider choice of governance to communities at the most local level. However, the Government considers that there is sufficient flexibility for principal councils not to feel "forced" to recommend that the matters included in every review must be implemented.

#### **CONCLUSION OF IMPACT ASSESSMENT**

#### **LEGAL IMPLICATIONS**

Chapter 3 of Part 4 of The Local Government and Public Involvement in Health Act 2007 devolved the power to take decisions about such matters as the creation/amendment of parishes and their electoral arrangements to local government and local communities in England. Principal councils are required, by Section 100(4) of the 2007 Act to have regard to guidance issued by the Secretary of State when undertaking reviews and the guidance has been followed in the drafting of this report.

Legal services will be consulted over the wording of the Reorganisation Order.

#### FINANCIAL IMPLICATIONS

An amount of £10,000 was included in the 2017/2018 budget and £25,000 in the 2018/2019 budget in order to resource this project. The costs of carrying out the consultations have been met within the budget provision that has been allocated. If, ultimately, a new parish is made there will be implications for council tax setting as the new parishes would have powers to precept, the same as other parishes within the district. Reaching a decision by October 2018 should allow sufficient time for council tax records to be updated prior to the release of the 2019/2020 charge notices. It is expected that the amendment of Council tax records could cost in the region of £15,000 and sufficient funding for this has been included within the budget allocation for 2019/2020.



Unless it gets the dozens of pot holes on Kingsway and Oxcliffe road fixed everything seems to be functioning as well as can be expected.
46	I did originally agree that this would be a good idea and told your canvasser but I have since changed my mind, I now do NOT agree with this.
47	Apologies for the lateness in this letter, but I have only just returned from a short camping break.
	I represent XXXX on Morecambe Town Council and quite a few local people have shown concern about the creation of Heysham Parish Council in the area where I live which is XXXX. I am also an active member of XXXXX, where quite a few of the

contingent have also shown concerns - all with the same view that all the money would be spent in Heysham Village.

What I am worried about is that when we were packing up our car for our short break a posse of Labour councillors and representatives armed with Labour clipboards descended into XXXXX where I live distributing Labour themed leaflets and were campaigning for the creation of Heysham Parish Council. I know: Labour hold the majority on Morecambe Town Council but surely playing the political card, shouldn't be allowed.

No literature was left at my home address, of which I'm not surprised, after the intimidation I received after the XXXX by election, of which I was told by the election office to withdraw my leaflet after a complaint of its content.

Literature was left at my mother's home which consisted of a Labour Heysham Matters newsletter, a leaflet from XXXX stating their intent to stand in 2019 for XXXXX, along with a LCC Do you want a parish council for Heysham leaflet.

I am slightly worried that the decision to create a Parish Council for Heysham is being created not for the benefits of the local Heysham people but for the benefit of a few influential people who seem to be able to get away with manipulating the system to their gain, both politically and financial.

Regarding the above matter. We regret that that we do not support the creation of a Parish Council for Heysham.

This is chiefly on two grounds 1, Cost and 2. The probability that such a Parish Council would most likely need to rely on existing County and City Council services to carry out its most important intended functions.

Many of these functions are statutory (like policing, highways maintenance and enforcement of byelaws for example) and we feel we pay enough at present (considering we are paying an extra £40 a year for garden refuse collection).

A specific example might be enforcement of the dog fouling byelaws by fixed penalty notices (something which is a particular cause of concern in Heysham). Surely such a Parish Council could only rely on your Environmental Health Department for such enforcement. It would probably not have the capability to attempt to serve fixed penalty notices on offenders itself.

On cost and value for money of the services we receive (or should receive), we are both concerned about things like the state of highways (dangerous pot holes in School Road-which we have made representations about to our ward County Councillor) and policing.

We appreciate that this is part of your Governance Review, which we congratulate you for instituting, but we cannot support the creation of another tier of local government which we feel will make little difference locally and add to our Council Tax liability.

With reference to organisations perception of the formation Heysham Parish Council.

So many questions, but I won't go on and on.

That precept (or income requirement) is then raised by charging a parish council tax rate to households within the parished area. As an indication of the tax rate that could be levied against each household in the area of the new parish, in the current year Band D parish tax rates range from £0 to £77.80 across the Lancaster district. The average parish tax rate is £27.58 per annum, I think it's very misleading and would like clarification before I make my INFORMED decision. 54 I wish to register my objections to the proposal to create a parish council for Heysham because -1. As I live in Heysham North ward, according to my Council tax bill, I am already paying for Morecambe Town Council and I refuse to pay for both. 2. Morecambe Town Council has proved to be a total waste of time and money as I knew it would be. This would be too. 3. The services they are proposing could be provided by the City Council. #### **RESPONSES AGAINST**

- With regards to the Community Governance Review and the proposed change of name of the above to Glasson & Thurnham Parish Council.
  - I strongly object to this proposal records relating to the Parish of Thurnham date back many hundreds of years with references to the Dalton family of Thurnham Hall in the 1600's

The Parish Council should continue to be know as Thurnham Parish Council. Old Glasson was a small farming and fishing community within the Parish of Thurnham.

- I am a resident in Thurnham and have just received a notice from you regarding the proposed change of name for Thurnham parish council. I have looked at your "Terms of Reference" document and there are several questions which I need to ask, and am asking for a reply to them by the end of this coming week.
  - 1) When this matter was discussed at the recent parish council meeting, what percentage of members voted for this change of name, and why they personally felt it best for our community?
  - 2) Thurnham is not only a village but also a parish which includes Glasson, Conder Green, Ashton and Stodday. By changing the name of the council, what practical difference will it make to the residents of these areas?
  - 3) Why was it decided to use the title "Glasson and Thurnham" and by whom? Thurnham should come first because it is a place that existed as far back as 1086 when it was named in the Domesday Book as Tiernum. Glasson, on the other hand, was initially just a few small cottages for local fishermen until the late 1700 's when the current dock and the Lancaster Canal came into existence. I did note that this new name seems to have already been adopted on page six of your "Terms and Reference" document which I regard as being a little bit premature.
  - 4) How much will this "proposed" change of name cost and where will the money come from?
- I refer to the recent communication from yourselves regarding the proposed name change of the parish council to include Glasson in the title. As a family, we strongly object to the whole procedure on many grounds.
  - Firstly, having read the Governance Review at length, we can see no benefit in simply changing the name to better reflect the area the council serves. No improvement in services will result from the change and the whole process seems a complete waste of money and time.
  - Surely, the manpower and monetary resources ploughed into sending all 294 properties the communication, would have been better spent on repairing potholes and emptying bins in the parish to name but a few. We have seen services dwindle and deteriorate over recent years and this appears to be a waste of money in such a difficult financial climate.

Why after many years, does a name change need to be undertaken? We have existed quite well under the title of Thurnham Parish.

Additionally, if one is getting really pedantic, when a map of the parish boundaries is looked at closely, it is strange to note that the new name does not include Conder

	Green. This too is a rural and residential area within the parish with its own local name. If the name is being changed to reflect the area, why is this not included in the title? We are not making a suggestion to have another proposed name change, but merely pointing out that even the new proposal is not a true reflection of the area so why make any change at all.
4	I object to the name change of my parish council to Glasson and Thurnham Parish Council.
	If the name is intended to 'better reflect the area it serves ' then the new parish council name should be :
	Glasson Dock and Thurnham Parish Council rather than the casual, vague and inaccurate 'Glasson '. This is not a place at all. We live in Glasson Dock, not 'Glasson ' which is an acceptable vernacular name but not the formal one required for a tier of local government.
5	I wish to confirm that I strongly oppose the name change from Thurnham Parish Council to Glasson and Thurnham Parish council. Glasson is a village in the parish of Thurnham and not an aligned parish. The title of Thurnham Parish Council has been adequate for generations and the un necessary, costly name change will not

The term "Glasson Dock" refers only to the Scheduled Ancient Monument of the Dock proper, comprising the east and west quays.  Further map evidence that the name of the village is "Glasson" as shown on the following Ordnance Survey maps:-  O/S Maps 1971 shows "Glasson"  Lancashire Sites and Monuments Record shows "Glasson"  O/S 1891 shows "Glasson"  Edition of 1919 shows "Glasson"  Glasson Cons Area shows "Glasson"  O/S 1955 Shows "Glasson"  O/S 1975 shows "Glasson"  O/S 1913 shows "Glasson"  Moreover according to a slightly out of date electoral register there approximately 216 voters in Glasson and just 14 in Thurnham — a fact which further supports your proposed name change.

	There are now considerably more houses in Glasson than in Thurnham which perhaps was not the case when the Parish Council was formed hundreds of years ago when Glasson was just a tiny hamlet.

The item I am interested in is the proposal to change the name of Thurnham Parish Council. Thurnham was a township before Glasson Dock existed. Glasson was a hamlet situated at Old Glasson Farm.

Glasson Village only came into being when the Port, the shipyard, the canal and the railway were established.

Thurnham Parish Council also incorporates Glasson, Conder Green and Ashton-with-Stodday and deals with matters concerning all the parish.

I understand concerns have arisen because there is another parish names Thurnham and is it causing confusion. The internet has much to answer for – no problems previously existed! If the name does have to change I would suggest it should be Thurnham with Glasson Parish Council to reflect the historical importance of Thurnham, rather than Glasson and Thurnham.
