Electoral Review: Local Boundary Commission's Consultation on Draft Warding Patterns

4 November 2021

Report of the Head of Democratic Services

PURPOSE OF REPORT

To consider whether or not to respond to the Local Government Boundary Commission for England (LGBCE)'s draft warding patterns for the City Council as part of the electoral review process, and, if so, to decide the nature of the response.

This report is public.

RECOMMENDATIONS

- (1) That Members note that the LGBCE is currently consulting on its draft proposals for warding patterns for the City Council.
- (2) That the Committee considers whether or not to make a response on behalf of the City Council, and, if the Committee decides that such a response should be submitted to LGBCE, to agree its comments and observations at this meeting if possible.

1.0 Background and Introduction

- 1.1 Council has granted Council Business Committee delegated authority to consider and approve responses to LGBCE consultations on behalf of the Council throughout this latest review.
- 1.2 Members may recall that, at the Committee meeting on 18 November, a response to the first stage of the LGBCE's review consultation on Council size was agreed, requesting that the size of Lancaster City Council remain unchanged at 60 members, providing a rationale for that view. The LGBCE confirmed its decision not to change the size of the Council and the review is proceeding based on 60 Councillors.
- 1.3 The Commission then asked for suggestions for warding patterns to be submitted. The Committee decided not to submit a response on behalf of the whole Council and encouraged individual political groups and Councillors to submit their own submit proposals and senior officers in elections to make a response on electoral administration issues. The Head of Democratic Services did submit that technical response to the Commission to meet the deadline.

1.4 The next stage of the process is for the LGBCE to consult on its draft warding patterns, which were published on 14 September 2021. A summary of the proposals is appended with maps.

2.0 Proposal

- 2.1 The Committee first needs to decide whether it wishes to make a submission on behalf of the Council, or whether this is best left to individual Councillors, political groups/parties and members of the public.
- 2.2 If the Committee feels that it is appropriate to make submission to the Commission, then Members may wish to use this meeting to formulate the comments to be submitted. If that does not prove possible, then it is recommended that the Committee agree the comments after the meeting via email.
- 2.3 The Head of Democratic Services and the Elections Manager will be in attendance at the meeting to respond to any questions from Members and discuss the proposals. However, please note that, as these are not the final proposals, it has not been possible for Democratic Services to resource a detailed examination of the proposals (not to street level, for example). That will be done once the final proposals are agreed. As electoral administrators, it is the job of Democratic Services to implement whatever is finally decided upon and use those new boundaries for the 2023 elections.

3.0 Conclusion

3.1 The Committee is asked to decide what, if any, consultation response it wishes make to LGBCE on behalf of the City Council at this stage. The deadline for responding to this stage of the Consultation is 23 November 2021.

Draft Recommendations on the new electoral

arrangements

We aim to propose a pattern of wards for Lancaster City Council which delivers:

- Electoral equality: each councillor represents a similar number of voters.
- Community identity: reflects the identity and interests of local communities. •
- Effective and convenient local government: helping your council discharge its responsibilities effectively.

A good pattern of wards should:

- Provide good electoral equality, with each councillor representing, as closely as possible, the same number of voters.
- Reflect community interests and identities and include evidence of community links.
- Be based on strong, easily identifiable boundaries.
- Help the council deliver effective and convenient local government.

Electoral equality

Does your proposal mean that councillors would represent roughly the same number of voters as elsewhere in the council area?

Community identity

- Transport links: are there good links across your proposed ward? Is there any form of public transport?
- Community groups: is there a parish council, residents association or another group that represents the area?
- Facilities: does your pattern of wards reflect where local people go for shops, medical services, leisure facilities etc?



- The total number of councillors representing the council's voters ('council size').
- The names, number and boundaries of wards or electoral divisions.
- The number of councillors for each ward or division

Why Lancaster?

 Lancaster City Council currently has high levels of electoral inequality: some councillors represent many more - or many fewer - voters than others.

Our proposals

• We propose that the council should have 60 councillors in future, representing 15 threecouncillor wards, five two-councillor wards, and five one-councillor wards across the council area.

You have until 23 November 2022 to have your say on the recommendations

Summary of our recommendations

Our draft recommendations propose that Lancaster Council should have 60 councillors, the same as the existing arrangements. Those councillors should represent 15 three-councillor wards, five twocouncillor wards and five single-councillor wards.

The boundaries of 15 wards should change. We are also proposing a number of ward name changes.

Before drawing up the draft recommendations, the Commission carried out a public consultation inviting proposals for a new pattern of wards for Lancaster City Council.

We have considered all of the submissions we received during that phase of consultation.

PURPOSE OF REPORT

To consider a timetable of committee meetings for the 2022/23 municipal year.

1.0 Background and Introduction

- 1.1 This Committee's terms of reference include "To agree the annual timetable of Lancaster City Council meetings and any other timetabling issues which may arise." (Constitution Part 2, Section 5, paragraph 8). A draft timetable is therefore presented to Members at this meeting to be finalised. This will allow accommodation to be booked and notice to be given of the proposed dates to Members and officers.
- 1.2 All meetings are being held at Morecambe Town Hall as this is the most effective way to keep meetings spaces well cleansed, reducing the health risks.
- 1.3 The Committee is asked to consider a referral from the Budget & Performance Panel, details of which are provided below.

2.0 Proposal

- 2.1 Proposed start times, venues and number of meetings are shown at Appendix 1. The draft timetable is shown at Appendix 2. It is based on the number of meetings held this municipal year.
- 2.2 It should be noted, however, that where the Personnel Committee and Standards Committee hold hearings in respect of individual cases, which are likely to last for a half day or more, and require the attendance of witnesses and others, such hearings are held during the day. This is because a 6.10pm start time is not practical.
- 2.3 At its meeting held on 6 October 2021, the Budget & Performance Panel made the following recommendation to this Committee:

That Council Business Committee be requested to amend the commencement time of Panel meetings held at Morecambe Town Hall to be moved from 6.10 p.m. to 6.00 p.m. and that when future meetings of the Panel return to Lancaster Town Hall the commencement time returns to 6.10 p.m.

The Committee is asked to consider the recommendation of the Budget and Performance Panel.

3.1 Members are asked to consider this report and agree a timetable of meeting dates, times, and venues for the 2022/23 municipal year at this meeting. If any significant changes are proposed, to make recommendations to Council.
