Subject: Application to extend the opening hours of German Doner kebab Lancaster

I am writing to object to the application regarding German doner kebab Lancaster extending its opening hours. I am a resident of the Diana Court apartments on Henry Street and the noise at night is already unbearable and opening the shop even later would further affect me and the other residents. Due to their being no parking for the shop its customers choose to park directly on the pavement of Henry Street which Is already a narrow street with double yellow lines. The noise of people parking up on the pavement (which is less than 2 metres away from My front room and bedroom windows) is already excessive as they get in and out of their vehicles, slamming their doors and talking loudly and when blocking the street they encourage other motorists to sound their car horns also causing excessive noise. Along with the traffic and noise issues the customers also seem to deem it OK to drop their litter out of their car windows after they have finished their meals. The staff also leave cigarette ends and hair nets in the street directly outside my front door. Currently the shop is open til 11pm which is the cut off for ant social noise levels, opening it any later would definitely affect me and the residents not just of Diana court but the various other apartments on Henry Street and I ask you take this into account when making your decision.

Good afternoon,

I am writing to object to the planning application of German Donner Kebab on Penny Street Lancaster extending its opening hours. I am a resident at Diana Court and both my bedroom and living room windows are no more than ten meters from GDK, and 2 meters from the road on Henry Street which runs down the side and back of the shop.

Since the establishment opened we have experienced a huge increase in traffic on Henry Street from customers accessing GDK. Cars parking on the double yellow lines block both the pavement and road outside my apartment, largely due to the lack of dedicated parking for the shop. The increase in traffic on Henry Street has meant our front door and the path leading to it are obstructed on a regular basis meaning you have to walk on the garden area to get into the building. The congestion leads to drivers beeping their horns late in the evening as they cannot get down the street, which continues late into the evening.

There is a constant sound of car engines and doors slamming on Henry Street which can be heard loudly from within my bedroom and living room which is caused by customers going to GDK and parking in the road. There are also raised voices and shouting from groups of customers going to and from GDK. Currently this starts to reduce after 11 when the shop closes but trying to sleep before that time is almost impossible. I work 9am-5pm and noise at this time outside the bedroom window is highly anti-social, which I anticipate would continue even later in the night should the opening hours be extended.

In addition to the noise levels there has been copious amounts of rubbish from the shop dumped outside my apartment, both in the garden area and in the street. This includes empty cardboard boxes of frozen chips, plastic gloves, cigarette butts from staff and hairnets which are not only messy but damaging to the environment. This is then made worse by customers eating their food from GDK in their cars while parked on Henry Street and dropping the empty packing in the street when they've finished. I can only anticipate longer opening hours would in turn lead to even more rubbish being left in the street and the garden areas of our apartment.

Anti social noise hours are currently from 11pm - 7am and this is just about bearable for residents of Diana Court and neighbouring apartment blocks but I am certain the noise would continue to late into the night past 11pm should the GDK opening hours be permitted for extension.

I hope you consider this when making a decision regarding the opening hours.

Subject: Planning Objection

To whom it may concern,

With reference to a planning application by German Doner Kebab, Penny Street, Lancaster, I am writing to object to the extension of their opening hours.

As a resident of Diana Court, Henry Street, I live opposite GDK.

The current opening times are just about tolerable, but any increase would mean unacceptable levels of noise and disturbance at night/early morning in what was, up until recently, a quiet residential street.

Since the opening of GDK, there has been an increase in the number of vehicles on Henry Street, which causes issues as it is only a narrow street with no designated parking for neither residents nor customers of GDK. These issues include parking on yellow lines, blocking the road if people park on both sides. People beeping their horns, keeping their engines running whilst waiting for takeaway food, and slamming car doors. This has already caused much disturbance to residents. There has also been an increase in waste food and litter on Henry Street.

The proposed extension of opening hours would mean noise and disturbance after midnight (and after 1 a.m. On Fridays and Saturdays.) Not only from potential customers, but from staff clearing up, taking bins out after closing hours.

As the cut off point for nuisance noise is 11 p.m, I feel the extension of opening hours would be totally inappropriate in a residential street.

In my view, this application should be rejected, on the grounds that no one should need to eat after 11 p.m. Especially when it is likely to cause distress and disturbance every night of the week to local residents. We have enjoyed almost twenty years on this site, on what was always a quiet street.
