# Consultation on the Draft National Planning Policy Framework

## 19 September 2024

## Report of Chief Officer - Planning and Climate Change

#### **PURPOSE OF REPORT**

To allow the Committee to consider the draft response to the Government's draft National Planning Policy Framework consultation.

This report is public.

#### **RECOMMENDATIONS**

(1) That the consultation response to the draft National Planning Policy Framework be agreed and formally submitted.

#### 1.0 Introduction

- 1.1 The Ministry for Housing, Communities and Local Government (MHCLG) have published a draft National Planning Policy Framework (NPPF) for consultation. The proposals represent the biggest change to the national planning system since the original NPPF was introduced in 2012.
- 1.2 The consultation was published on 30 July 2024, and since then Officers have been compiling responses to the 106 questions. As part of this process, the views of Elected Members have been considered (see paragraphs 3.1 to 3.4 of this committee report).
- 1.3 The deadline for the submission of comments to the MHCLG is 24 September 2024.

#### 2.0 Proposal Details

- 2.1 Officers have produced an explanatory note which is appended to this report. This sets out the key issues arising from the consultation, and how the proposals will likely affect the Lancaster District. The Note includes a link to the draft NPPF (Paragraph 1.4). This document is **Annex 1.**
- 2.2 **Annex 2** comprises all 106 consultation questions, repeated in full, with the draft answers provided by Officers following the consultation with Members. It is this document that is proposed to be submitted to MHCLG as Lancaster City Council's formal observations.

#### 3.0 Details of Consultation

- 3.1 Members of the Planning Regulatory Committee were presented with an explanatory report and the draft responses to the consultation questions on 2 September 2024.
- 3.2 Members of the Local Plan Review Group received a similar report and the draft responses to the consultation questions on 10 September 2024.
- 3.3 Members of both of these groups are well-versed in terms of planning considerations and the plan-making system. Their observations have formed a valuable part of the consultation response drafting process.
- 3.4 Separately, Cabinet Members have also had an opportunity to input into the draft response.
- 3.5 As a matter of courtesy, the local planning authority also wrote to inform all Parish and Town Councils of the consultation opportunity (sent by email, 2 August 2024). This letter included details of where individual Parish and Town Councils could make representations (i.e. directly to the MHCLG).

#### 4.0 Options and Options Analysis (including risk assessment)

- 6.1 The Council's approach to compiling the draft NPPF consultation response has involved Officers and Members, and I would like to take the opportunity to thank everyone for their valued input. The attached document represents a comprehensive and considered response and it is therefore recommended that it is formally submitted to MHCLG.
- 6.2 The MHCLG has indicated that it will publish a response to the consultation and a revised NPPF "in the autumn, so that policy changes can take effect as soon as possible". At that point, Elected Members will receive further briefings from Officers.
