36 APPEAL AGAINST REFUSAL OF A REGISTRATION AS A SECURITY PERSON AT PREMISES LICENSED FOR PUBLIC ENTERTAINMENT – STUART SHAND

The Committee considered an appeal against a decision of the Licensing Regulatory Committee to refuse Mr Shand's application for registration as a security person at premises licensed for public entertainment.

That Mr Shand's appeal be allowed but his doorstaff registration be granted for 6 months only. At the end of the 6 month period Mr Shand must apply to renew his registration in the usual manner.
