PURPOSE OF REPORT

To appoint three non-executive Champions for the four year period 2015/16 to 2018/19, as detailed in the report.

RECOMMENDATIONS

 - Older People
 - Children and Young People
 - Veterans

be appointed by Council for the four year term 2015/16 to 2018/19.

1.0 Introduction

- 1.1 On 17 July 2013, Council formalised the arrangements for Member Champions in Part 6 of the Constitution as a non-executive role. The Council currently has Champions for three distinct areas: Older People; Children and Young People and Veterans.
- 1.2 On 12 May 2014, Council resolved:

"That, when appointments are made for 2015/16, their term of office be extended from one to four years, to enable the champions to develop their knowledge and carry out their duties over a longer period."

2.0 Proposal

2.1 A Champion is a non-executive councillor appointed by Council at its annual meeting to provide a focus on a specific area of the Council's business or where a community group needs to ensure it is given due regard in relation to the activities of the Council and its partners in local governance.

2.2 Councillors may be re-appointed and there is no limit to their term of office. The Champions appointed for 2014/15 were:

Older People – Councillor Margaret Pattison Children and Young People – Councillor Joyce Taylor Veterans – Councillor Liz Scott

2.3 Appointments made at this meeting will be for a four year term, in accordance with the Council resolution above (minute 17 refers).

4.0 Conclusion

4.1 Council is asked to appoint Champions four year term 2015/16 to 2018/19. Only non-Cabinet Members may be nominated.
