# **Report of Chief Officer (Environment)**

## PURPOSE OF REPORT

To provide information on CCTV system operated by Lancaster City Council as per the committee's request.

#### RECOMMENDATIONS

#### 1.0 Introduction

- 1.1 The Committee has previously requested information on the Council operated CCTV system. This information is attached at Appendix A.
- 1.2 At this stage in the report the committee should note that on 19<sup>th</sup> Jan 2016 that as part of their budget proposals Cabinet recommended that the Council no longer funds the public CCTV system from 2017/18. The actual wording is a follows-

With regard to CCTV, notice would be given as soon as possible to terminate the relevant services contracts, but within the notice period and prior to actual decommissioning of the equipment any approaches made by organisations interested in taking on the operation (at no cost to the Council) would be appraised and considered.

Cabinet recognises that at a time of Government cuts, this Council cannot continue to provide the existing funding required to maintain and/or renew the existing CCTV system in the Lancaster district from April 2017, but asks Officers to make enquiries with other organisations to see if they may be in a position to get involved in maintaining either an externally staffed or volunteer-led CCTV system.

1.3 The provision of a public CCTV system by the Council is entirely

discretionary.

- 1.4 The Council has statutory duties with regards to community safety, and also has 'Clean, Green and Safe Places' as a corporate priority. Even without a CCTV system the Council's responsibilities and aims would be more than covered in these areas.
- 1.5 Operationally the main beneficiary from CCTV is Lancashire Constabulary. Unlike some Police forces Lancashire Constabulary's policy is not to provide or directly fund public CCTV systems.
- 1.6 Since the public CCTV system was commissioned many retail and licensed premises have put in place their own CCTV systems. Besides this the vast majority of members of the public have the ability to video using their mobile devices.
- 1.7 Appendix A provides more detail on the actual system but members should note the following main points-
  - The system currently costs £165,000 per annum in direct costs per year to run. Of this £83,000 covers the cost of the contractor who staffs the system, £28,000 covers the cost of the link into BT's fibre optic network, £53,000 covers the cost of the maintenance and repairs of the cameras, monitoring and recording systems leaving a nominal amount for electricity, equipment and subscriptions.
  - As technology has advanced the system has gone beyond the point where it needs to be renewed. Anticipating the financial pressures faced by local government, and the need to provide a range of options for ongoing savings major spend has been held off in this area. Spare parts for cameras etc have been recycled from other cameras. There have been several occasions where the system has gone down and needed a 'sticking plaster' approach to get it operational again. Several cameras no longer work.
  - We estimate that a new system would cost a minimum of £185,000.
  - This one off cost clearly creates a financial pressure. There are also some potential sources of external funding that could contribute to that.
  - The more significant financial pressure though is the ongoing revenue cost. It is expected this would be reduced with an upgrading system. Nonetheless it would still leave a significant ongoing revenue cost, at a time when the Council's financial pressures have never been greater.
  - Even if funds were identified to upgrade the system the Council would effectively be financially committed for the long term. It may well be that other partners would contribute to such a project, but as long as the responsibility rests with the Council it would be committed to it.
  - Some of the Districts in Lancashire are looking at a shared CCTV project. This is on the back of a wider project that the Council was not involved in. Even with a shared project there will of course still be a requirement for officer capacity, one off costs and ongoing revenue costs.
- 1.8 As things stand the Council is not tied into any long term commitments, which obviously provided Cabinet with a timely opportunity to make a clear decision on its future.
- 1.9 Information on how other Districts operate CCTV has been requested and will be outlined at the meeting.

#### **APPENDIX A**

#### **Background Information**

The public space CCTV system is a Closed Circuit Television System and is a true closed end to end system consisting of cameras in Lancaster and Morecambe connected via fibre optic cables to the Control Room situated at Lancaster Police Station. The vast majority of the cameras were installed circa 1996, 1997 and 1998 with additional cameras installed in 2001 and 2004.

The current CCTV system costs £165,000 per annum in direct costs to operate and maintain. No income is generated or contributions received towards running costs. The Police provide the accommodation at Lancaster Police Station.

Cameras are located as follows:-

**Lancaster** - 18 cameras covering the City Centre with a further 2 cameras on Ryelands and 1 on the Ridge; 2 further internal cameras are located in the Bus Station. **Morecambe** - 13 cameras covering the Town Centre, along the Promenade and 5 cameras in the West End.

#### **Current Operation, Control Room and Communications**

The CCTV cameras operate and record on a 24/7 basis and the Control Room is manned 100 hours per week. Additional staff can be deployed for specific events if required. An Editing Suite is also available to check footage which is retained for 30 days.

The Council follows all legal requirements and complies with the relevant Codes of Practice

The Control Room has 9 wall monitors and 2 spot monitors that can be used by the operators for viewing specific incidents. The views seen on the spot monitors can also be seen by Police Communications staff at Police HQ so if there are any specific incidents occurring in Lancaster or Morecambe, the Police can observe and direct resources accordingly. The CCTV operators also have access to the Police radio system and Pub Watch and Shop Watch radio frequencies for both Lancaster and Morecambe.

The CCTV staff work very closely with the Police and PCSOs and provide assistance in the prevention of crime, deterring and detecting crime and helping the Police to direct resources as appropriate. The cameras are also used for the wider management of incidents, events, town and city centre management and public realm issues, and the operators can help to direct resources to support the Council's priorities.

During 2015 the CCTV operators dealt with nearly 4,000 logs, reports and incidents.

#### **Current Position and Upgrade Options**

The cameras and the operating system that controls them are now at the end of their working life. This has led to some unexpected essential maintenance in the last 2 years and 4 cameras are no longer working. Other equipment is in a vulnerable condition due to its age and limited availability of spare parts. Upgrading the system is therefore required to ensure it is fit for purpose. Refurbishment of the CCTV Control Room is also required.

Options for replacing the operating system and the cameras and refurbishing the Control Room have been investigated and the approximate cost for each option is shown below:-

- Replace all the equipment with an IP (internet protocol) high speed broadband system and replace all the cameras – circa £350k This option would be subject to a communications survey by a broadband service provider but the cost of using the current BT fibre optic services of £28k per annum could be saved
- 2) Replace all the equipment with a new analogue system, similar to the existing system, and replace all the cameras **circa £185k**
- 3) Adopt a 'Pay as You Go' approach and replace all obsolete and vulnerable parts of the operating system and the cameras that have failed with analogue equipment – the cost in Year 1 would be circa £50k. It is suggested that approximately £50k per annum should be allocated for a further 3 years to complete the upgrades but this figure is largely dependent on how long the existing equipment can be maintained. This option is subject to a further technical feasibility exercise.

#### Decommissioning the CCTV System

In the event of the Council deciding to discontinue the CCTV system the columns and cameras would need to be decommissioned and removed from each site and the sites reinstated. A provisional budget figure of **£80k** has been estimated but this figure could potentially be reduced if a single contractor was appointed to carry out all the work. No allowance has been made at this stage for removing the buried concrete blocks that were constructed to support each column. Likewise, no allowance has been made for redundancy costs. In addition notice would need to be given to the contractor responsible for staffing the CCTV room.
