#### **URGENT BUSINESS – ELECTION OF CABINET MEMBER**

I have been advised that Councillor Val Histed intends to resign from Cabinet. It has been proposed by the Conservative Group that Councillor Tony Johnson replace her. At the present time I am awaiting written confirmation from Councillor Histed, but I am seeking your approval in anticipation for Councillor Johnson to replace her, in accordance with the Council's Urgent Business Procedure. With Cabinet being based on PR it is for the Conservative Group to make the nomination.

The urgency for this decision is to enable the replacement Cabinet Member to be in place before the next meeting of Cabinet on Tuesday, 11<sup>th</sup> December 2007; it not being in the best interests of the Council's decision making processes to require interim portfolio holder arrangements for the period to the next meeting of full Council.

The recommendation is:

- (1) That the resignation of Councillor Val Histed as Cabinet Member be noted.
- (2) That Councillor Tony Johnson be elected as the Conservative Group Cabinet Member for the remainder of 2007/08 to fill the resultant vacancy.
