<b>Details of Decision:</b> That Hirst and Danson Ltd be appointed as the Council's contractor to undertake the electrical refurbishment of parts of Lancaster Town Hall.								
Reasons for the decision:								
Cabinet authorised additional repairs to municipal buildings in December 2009. The lowest tender was submitted by Hirst and Danson which is £7K below Capita Budget price and £22K below the next closest tender. Because of this difference Capita Symonds contacted Hirst and Danson and requested that they examine their tender and confirm that they are happy with their price. Hirst and Danson have so confirmed. Capita Symonds therefore can see no reason why this tender should not be accepted, but Capita Symonds do feel that the price is extremely competitive.
