Details of Decision:

That Flatroofing Systems be awarded the contract for the roof works to Lancaster Town Hall as outlined in the tender brief.

Reasons for the decision:

Cabinet resolved on 8 December 2009 to reaffirm the need to invest in the condition of municipal buildings. Funding was included in the 2010/11 budget for Corporate and Municipal Building Works. Works to the roof at Lancaster Town Hall form part of this.

Tenders were issued for work: Include removal of existing roof coverings and replacement with new slate including the removal of existing roof-lights, replacement of existing rainwater goods, Solar Panels and lead work, structural works to parapet walls and re-pointing to internal light-wells.

Flatroofing Systems are proposed for acceptance because they submitted the lowest tender which was found to be extremely competitive.
