Local Government (Miscellaneous Provisions) Act 1976 Private Hire Vehicle Licensing – Request for Waiver of Licence Conditions Requiring Display of the Council's Uniform Signage 4th June 2015

Report of Licensing Manager

PURPOSE OF REPORT

An application for a private hire vehicle licence has been received from Mr. D Rabbett. Along with his application the applicant has requested a waiver of the standard licence condition requiring the display of the Council's uniform signage. The purpose of this report is to enable Members to consider the request.

RECOMMENDATIONS

The Committee is requested to determine, in the light of the representations made, whether to allow the applicant's request for a waiver of the standard vehicle licence conditions requiring the display of the Council's uniform door signage and plates.

1.0 Introduction

- 1.1 Under section 48(2) of the Local Government (Miscellaneous Provisions) Act 1976, a District Council may attach to the grant of a licence under this section such conditions as they may consider reasonably necessary including, without prejudice to the generality of the foregone provisions of this subsection, conditions requiring or prohibiting the display of signs on or from the vehicle to which the licence relates under Section 48(6) of the above Act. Any person aggrieved by the refusal of a District Council to grant a vehicle licence under this Section, or by any conditions specified in such a licence, may appeal to a Magistrates' Court.
- 1.2 For the purpose of the above, the Council has established conditions attached to the grant of a private hire vehicle licence.
- 1.3 Members will note that condition No. 3 of the standard conditions provides that a plate "shall be securely fixed to the rear of the vehicle in a conspicuous position and a further plate should be fixed at the front of the vehicle.

 Door signs supplied by Lancaster City Council must be affixed to the front doors of the vehicle."

- 1.4 The purpose of plates and uniform signage is to enable members of the public to identify licensed vehicles, and also to differentiate between a hackney carriage and a private hire vehicle. It is considered that such signs are essential from a public safety point of view.
- 1.5 An application for a private hire vehicle licence has been received from Mr. H Rabbett. In his application, Mr Rabbett has proposed to license a Skoda Superb Elegance. The vehicle has been granted a licence which commenced on 7th May 2015 and is currently subject to all of the standard conditions relating to signage, Mr. Rabbett has requested a waiver of the standard licence conditions requiring the display of the Council's uniform door signage on the grounds that he is operating executive travel for business and holiday travellers. A copy of Mr Rabbett's request is attached at appendix 1 to this report.
- 1.6 For information Mr Rabbett was granted a waiver of this condition in relation to this vehicle and an exclusive contract in 2012. That waiver has now been transferred to a new vehicle which Mr Rabbett has now licensed to carry out that exclusive contract.
- 1.7 Members would not normally grant an exemption of this sort unless they were satisfied that the vehicle was being used only for an exclusive contract and Mr Rabbett's letter attached does not confirm this to be the case with this vehicle. Other operators offering airport services have always been refused this exemption, on the basis that the signs are required to protect the safety of the public. Allowing a private hire vehicle to operate without signs would, in officers' view, be a dangerous precedent, as members of the public would no longer be able to rely on the fact that a licensed vehicle will always display a uniform council sign.
- 1.7 Mr. Rabbett has been invited to attend the meeting to make representations in support of his request. Arrangements are also being made to enable Members to view the applicant's vehicle prior to this meeting.

2.0 Conclusion

- 2.1 Members are asked to consider whether they are satisfied to allow the applicant's request for a waiver of the standard licence conditions requiring the display of the Council's uniform door signage and plates. If the waiver is granted Mr Rabbet will be required to keep the rear plate in the boot of the vehicle and display an internal card on the dashboard of the vehicle.
- 2.2 Officers would recommend that this request is refused unless Mr Rabbett can demonstrate that the vehicle will only be used to carry out an exclusive contract, as the condition on signage was introduced to enable licensed vehicles to be easily identifiable to members of the public in the interest of public safety.

Highways Act 1980 Street Café Licence – Diggles, Market Street, Lancaster Request for Variation of Standard Conditions in relation to Permitted Times 4th June 2015

Report of Licensing Manager

PURPOSE OF REPORT

An application for a Street Cafe Licence licence has been received from M F Diggle. Along with his application the applicant has requested a variation of the standard licence condition which allows the street cafe to operate between the hours of 10am and 8pm, to allow him to operate from 7am.

RECOMMENDATIONS

The Committee is requested to determine, in the light of the representations made, whether to allow the applicant's request for a variation of the standard licence condition in relation to the permitted times of operation for the street cafe licence to allow him to operate from 7am instead of the standard 10am.

1.0 Introduction

- 1.1 The Council grants permissions for Street Cafe Licences under Section 115E of the Highways Act 1980. Under Section 115F of the same Act, a District Council may attach to the grant of a licence under this section such conditions as they may think fit.
- 1.2 For the purpose of the above, the Council has established conditions attached to the grant of a Street Cafe Licence.
- 1.3 In relation to this application condition 4 states:-
 - The use of the Licensed Area shall cease before 20.00 hours each day and shall not commence prior to 10.00 hours.
- 1.4 The purpose of this condition is to keep the areas clear of obstruction to allow vehicular access for service vehicles and to allow street cleansing before the commencement of operation of the cafe where necessary.

- 1.5 Mr Diggle has now submitted a request to operate his Street Cafe area from 7am. He has stated on his application form that the only place he has to store his street cafe furniture is within his premise. His premise opens at 7am and he claims that without this variation he would not be able to operate a street cafe as he would not have anywhere to store his furniture. The street cafe would be located outside of his premises on Market Street, Lancaster. A copy of the application is attached at appendix 1 to this report, along with a plan of the area.
- 1.6 As part of the application process County Highways officers and Council Planning officers as well as other businesses in the area of the frontage have been consulted. Planning officers have not objected to this particular variation; however they have stated that they would not like to see it set a precedent, as some areas need to be kept clear to allow access to service vehicles and to allow street cleansing to take place. A copy of the response is attached at appendix 2 to this report.
- 1.7 At the time of writing this report no objection from County Highways or any other person has been received. However the closing date for representations is the 28th May and should any representations subsequently be received they will be added to the agenda.
- 1.8 Mr. Diggle has been invited to attend the meeting to make representations in support of his request.

2.0 Conclusion

2.1 Members are asked to consider whether they are satisfied to allow the applicant's request for variation of the standard condition and to allow the Street Cafe at Diggles, Market Street, Lancaster to operate from 7am instead of the standard 10am.

Morning Mark

From the regeneration perspective, inc for public realm considerations, LSR etc, comments as follows -

No issues with the spatial extent of the street café, indeed I welcome the 'extension' into Market Street. As existing it is very restricted and the proposed will fit well with the street layout. Regarding the request for the time variation the application is not clear about what is sought exactly but I assume this is from 7.00 am. If so this is very early and out of line with the operation of street cafes licensed to date in the city centre, so to agree the application would set something of a precedent. This said I understand the reasoning for seeking the time variation and in principle have no problem with it. The only possible issues it raises are whether the earlier operation would constrain the ability to clean the street surface in the café area or unduly constrain the movement of servicing vehicles. I would have thought that if the former is an issue it could readily be managed. As regards the latter while I can forsee that in some locations within the city centre the operation of a street café so early might constrain servicing vehicles I don't anticipate any such problem in this instance given the width of Market Street here. In my view therefore the time variation might be supported in this specific instance but it will be important to be clear that this should not be read as setting any precedent.
