6 COMPLAINT OF BREACH OF THE CODE OF CONDUCT

In the course of discussion, members indicated that they accepted the investigating officer's findings that the code of conduct had been breached, and considered a subsequent course of action.

Resolved:

- (1) That the investigating officer's findings be accepted, and that the report be made public subject to redactions to safeguard personal data.
- (2) That, in accordance with the Committee's role in assisting the Council to fulfil its duty under the Localism Act 2011 to promote and maintain high standards of conduct by members, the redacted report be referred to full Council, to remind members of the requirement in the Council's code of conduct for members to notify the Monitoring Officer within 28 days of any new disclosable pecuniary interest or any change to an existing disclosable pecuniary interest, and to remind members of the Committee's expectation that any member who is the subject of a code of conduct complaint will co-operate with the investigating officer's inquiries.
- (3) That the Monitoring Officer be requested send a copy of the report to the Monitoring Officer of the County Council for the information of the County Council's Standards Committee.
