Award of a new 3 year contract to Civica for the current income management system.			
Reasons for the decision:			
The current contract expires on 31 March 2015, but due other work priorities and resources a full tender has not been appropriate during this financial year. Following negotiations the current supplier has offered a new contract for a 3 year period at a cost less than currently budgeted. An exception to tender has been completed and approved. It should be noted that a full tender process will be completed prior to the expiry of the new contract.			
The new contract will come into effect from 01 April 2015, however the current price offered is only valid until around the middle of January 2015.
