Broadfields Park Caravan Site Licence Review Update 24 November 2016

Report of Chief Officer (Health & Housing)

PURPOSE OF REPORT

To advise Members of recent significant developments relating to drainage and sanitation at Broadfields Park

RECOMMENDATIONS

(1) That Members note the contents of this report

1.0 Introduction

1.1 Members will recall the report submitted to Licensing Regulatory Committee on 2 June 2016 seeking decisions about varying the licence conditions for Broadfields Park. Members approved the variation of licence conditions on the site licence to improve standards relating to drainage and sanitation.

2.0 Recent Developments

- 2.1 The site licence with varied conditions attached, as approved by LRC, was duly given to Britaniacrest Ltd, being the operator and licensee at Broadfields Park. Under the Caravan Sites and Control of Development Act 1960 (as amended) site owners have a right of appeal to a First Tier Tribunal against decisions to vary licences. On 4 August 2016 the council was notified by the Tribunals Service that an appeal application had been received from Britaniacrest Ltd. If there is an appeal against conditions that require specific works to be done by certain dates, as in this case, those conditions are suspended until the appeal is decided.
- 2.2 On 7 November 2016, however, council officers were informed by United Utilities that due to a change in legislation the pumping station and rising main on Broadfields Park had been transferred to Unitied Utilities' ownership on 25 October 2016. This means that the issues the licence variation was seeking to address now lie with United Utilities and not Britaniacrest Ltd.
- 2.3 For this reason council officers have written to the Tribunals Service seeking to withdraw the council's opposition to Britaniacrest Ltd's appeal and in turn

Britaniacrest Ltd have now confirmed their wish to withdraw the appeal.

2.4 The council has no powers of enforcement over United Utilities but has asked for their proposals in connection with Broadfields Park's sewerage.

5.0 Conclusion

5.1 Since 25 October 2016 the pumping station and rising main on Broadfields Park are the responsibility of United Utilities, not Britaniacrest Ltd. It is therefore no longer appropriate to vary the site licence conditions to require Britaniacrest Ltd to improve drainage and sanitation issues. The site licence will now revert to the licence in place prior to the variation.

Highways Act 1980 Street Café Licence – Greggs, 9 Cheapside, Lancaster Request for Variation of Standard Conditions in relation to Permitted Times 24th November 2016

Report of the Licensing Manager

PURPOSE OF REPORT

An application for a Street Cafe Licence has been received from Greggs PLC. The applicant has also requested a variation of the standard licence condition which allows a street cafe to operate between the hours of 10am and 8pm, to allow them to operate from 7am each day of the week.

RECOMMENDATIONS

The Committee is requested to determine in the light of the representations made, whether to allow the applicant's request for a variation of the standard licence condition in relation to the permitted times of operation for the street cafe licence to allow them to operate from 7am to 8pm instead of the standard condition 10am to 8pm

1.0 Introduction

- 1.1 The Council grants permissions for Street Cafe Licences under Section 115E of the Highways Act 1980. Under Section 115F of the same Act, a District Council may attach to the grant of a licence under this section such conditions as they may think fit
- 1.2 For the purpose of the above, the Council has established conditions attached to the grant of Street Cafe Licences.
- 1.3 In relation to this application condition no.4 states:The use of the Licensed Area shall cease before 20.00 hours each day and shall not commence prior to 10.00 hours.
- 1.4 The purpose of this condition is to keep the areas clear of obstruction to allow vehicular access for service vehicles and to allow street cleansing before the commencement of operation of the cafe where necessary.

- 1.5 Greggs PLC have now submitted a request to operate their Street Cafe area from 7am Mondays to Sundays. This is to facilitate and enhance early morning breakfast trade and allow their customers the choice of consuming non-alcoholic beverage with food outside, weather permitting.
- 1.6 The Street Cafe would replace the existing one located outside of their premises on Cheapside in Lancaster, which has been in operation since 5th March 2015. A copy of the application is attached at appendix 1 to this report.
- 1.7 As part of the application process County Highways officers, Council Planning and Environmental Services officers, the Police, as well as other businesses in the area of the frontage have been consulted.
- 1.8 The closing date for representations was the 6th October 2016 and whilst no representations were received, County Highways noted they would not wish to see any conflict with vehicular access for unloading purposes to neighbouring businesses or for City Council street cleansing
- 1.9 Greggs Plc have been invited to attend the meeting to make representations in support of their request.

2.0 Conclusion

2.1 Members are asked to consider whether they are satisfied to allow the applicant's request for a variation of the standard condition and to allow the Street Cafe at Greggs PLC, 9 Cheapside, Lancaster, to operate from 7am until 8pm instead of the standard 10am until 8pm.





Points Raised at the Taxi Surgery in October 2016 24th November 2016

PURPOSE OF REPORT

At the request of the chairman, to inform the Committee of action taken in relation to points raised by some members of the trade at the recent Taxi Surgery

This report is public

RECOMMENDATIONS

- 1.0 That members note the comments in the report in relation to action taken following issues raised at the recent Taxi Surgery.
- 1.1 Some members may recall that at the Taxi Surgery held in October 2016, some members of the trade raised issues in relation to out of hours enforcement of taxi ranks in Morecambe and Lancaster.
- 1.2 The drivers pointed out to members that night time ranks in Morecambe and Lancaster could not be used properly by hackney carriage drivers due to private vehicles continuously parking on them.
- 1.3 Specifically mentioned was the new rank opposite the Clock Tower in Morecambe and the ranks on Sun Street and North Road in Lancaster, however licensing officers are aware that there is also a problem on the rank on Brock Street in Lancaster outside what used to be Bensons for Beds.
- 1.4 This report has been prepared to inform members of what action can and has been taken by licensing officers and what action is planned to try and address this problem.
- 1.5 The taxi drivers at the surgery commented about the signage at the ranks and asked if that could be improved, however the licensing manager has made enquiries with the Highways Department, who have confirmed, as was suspected, that the signage is authorised by the DFT and cannot be changed.
- Licensing officers cannot hand out fixed penalty notices in relation to parking on ranks, however Section 64 of the Local Government (Miscellaneous Provisions) Act 1976 makes it an offence for any vehicle other than a hackney carriage vehicle to wait in a rank. If any person contravenes the provisions of the section, without reasonable excuse, they are guilty of an offence.

- 1.7 Using the above section of the legislation licensing officers have been ascertaining the names of the keepers of vehicles which have been photographed parked illegally on the taxi ranks in Morecambe and Lancaster by using a DVLA check, and warning letters have been sent to the keepers of the vehicles. Seventy seven warning letters have been issued since April 2016. A copy of the letter is attached at appendix 1 to this report. To date no one who has received an initial letter has re-offended.
- 1.8 Out of hours operations have been planned with the support of the Lancashire Constabulary. However at short notice the officer allocated to work with licensing officers on the first such operation was re deployed at the last minute due to an emergency, further operations are planned over the next few weeks. Licensing officers did work alone, and monitored the ranks, moving people on when they tried to park there. Additionally officers have done a separate out of hour's operation during which they were accompanied by an officer of the Lancashire Constabulary who issued seven fixed penalty notices in relation to vehicles obstructing the hackney carriage ranks.
- 1.9 A request has been made to Lancashire County Council for civil enforcement parking support officers to work out of hours alongside licensing officers to issue penalty charge notices and help to eradicate this problem.
- 1.10 A further point was raised in relation to the operations at the private hire company on Queen Street. The drivers commented that someone with a clip board stands outside of the office and takes the bookings. This is not unlawful and is quite common in most towns and cities at peak times. As long as the vehicle has been pre-booked, and details of the booking are kept the operators are complying with the legislation.

I am writing to you as the registered keeper of the above vehicle.

Section 64 of the Local Government (Miscellaneous Provisions) Act 1976 (the Act) prohibits any vehicle other than a hackney carriage vehicle from waiting on any stand for hackney carriages during any period for which that stand has been appointed, or deemed to have been appointed by a District Council under section 63 of the Act. Any person who contravenes this provision shall be guilty of an offence.

The area in question has been duly appointed as a rank between the hours of (insert times).

This letter is being sent to you at this time to point out the legislation and to warn you of the consequences of parking a vehicle on a taxi rank. However any further contraventions following receipt of this letter could be dealt with less leniently and may lead to prosecution.
