## 20 B AND Q SUPERSTORE, ALDCLIFFE ROAD, LANCASTER

Relevant Demolition of existing retail building (A1) and associated water tank and enclosure, and the erection of a food store (A1) with associated car parking, external plant and enclosure, servicing areas and hard and soft landscaping.

Castle Ward A

A site visit was held in respect of this item on 28<sup>th</sup> January 2019 minute 112 (2018/2019 refers).

Under the scheme of public participation, Romy Clark spoke against the application and Malcolm Ball spoke in support. The Applicant Representative Adam Robson Property Director at Aldi then spoke in support of the application.

It was proposed by Councillor Robert Redfern and seconded by Councillor Janice Hanson:

"That subject to no new and valid planning considerations being raised during the further period of public consultation ending on 5<sup>th</sup> July, which are not considered in the report or as part of the Committee's consideration of the application at the Committee meeting, planning permission be granted subject to the conditions in the report, an amendment to the condition for a Service Delivery Management Plan to include details of waste management and extra conditions controlling the hours of construction and restricting permitted development rights"

Upon being put to the vote, 11 Councillors voted in favour of the proposal, with 3 abstentions, whereupon the Chair declared the proposal to be carried.

#### Resolved:

That subject to no new and valid planning considerations being raised during the further period of public consultation ending on 5<sup>th</sup> July, which are not considered in the report or as part of the Committee's consideration of the application at the Committee meeting, planning permission be granted subject to the following conditions:

- 1. Time limit (3 Years).
- 2. Approved plans list.

#### **Pre-commencement conditions**

- 3. Construction of site access and off-site highway works.
- Submission of Tree Protection Plan and Arboricultural Method Statement.
- 5. Site Investigation for contamination.
- 6. Surface water drainage scheme to be agreed limiting discharge rate to 20 litres per second.
- 7. Written Scheme for Investigation (Archaeology).
- 8. Precise details plant equipment, vents, ducts and their enclosures.
- 9. Employment Skills Plan.
- 10. Development to accord with the ecological recommendations set out in the submitted and approved Ecological Appraisal.

## Pre-construction of the building (above ground level) conditions

- 11. Precise details (and samples) of all external materials to the building, enclosures, boundaries and surface treatments to be agreed.
- 12. Scheme for external lighting and security measures (CCTV).
- 13. Precise scheme for refuse provision.
- 14. Precise scheme for the provision of EV charging facilities and cycle provision.
- 15. Precise details of the ecology and habitat mitigation and enhancement measures to be agreed.

#### Before first use/opening of the store

- 16. Surface water drainage management and maintenance condition.
- 17. Car Parking Management
- 18. Service Delivery and Waste Management Plan.
- 19. Car, cycle, motor cycle provision to be provided and retained.
- 20. Travel Plan.

#### **Control conditions**

- 21. Foul and surface water to drain on separate systems.
- 22. Net sales shall not exceed 1,300 sqm. No more than 20% of the net sales floorspace shall be used for the display and sale of comparison goods.
- 23. Hours of operation limited to 08:00 22:00 Monday Saturday and 09:00 17:00 Sundays and Bank Holidays.
- 24. Hours of deliveries limited to 07:00 22:00 Monday Saturday and 09:00 17:00 Sundays and Bank Holidays.
- 25. Landscaping condition to be implemented and maintained.
- Noise mitigation and noise levels for plant to be secured and maintained.
- 27. Hours of construction limited to 08:00 18:00 Monday Friday and 08:00 14:00 Saturday.
- 28. Removal of Permitted Development rights.

- 7. Off-site highway works contraflow cycle lane on Blades Street.
- 8. Landscaping Management Plan.
- 9. Retention of materials/details, including noise mitigation measures and boundary treatments.
- 10. Maintenance and management of surface water and foul drainage systems.
- 11. Removal of PD rights (Part 1 Classes A to G, Part 2 and Part 14).
