Reasons for the decision:					
Three companies submitted tender documents via the YPO framework to supply these vehicles. Riverside Truck Rental were the only supplier who could achieve all of the specific criteria, including the provision of a 7 year (full vehicle life) chassis and battery warranty, which we valued as critical within the tender process.					
Approval to spend was granted at the Budget Council on 26 th February 2020.					
Prices were quoted for chassis, body, staff training and aftersales.
