Details of Decision:  Procurement for 6 electric pool cars to be provided by Vauxhall					
Reasons for the decision:					
The vehicle tender took place via The Chest. A specification of requirements developed for x6 electric pool cars. Evaluation included percentages for price, warranty, service and locality (local wealth building). Winning supplier: Vauxhall. Servicing of cars to be done at Arnold Clark, Morecambe (3 years). Since the process started manufacturers have increased the battery capacity of their cars, with a consequent increase in purchase cost. Combined with the impact of COVID on business travel this means we have reduced the amount of cars originally intended for the project.  Cabinet authorised officers to complete the award of contract in accordance with the 'Covid-19 Pandemic-Policy for decision making and spending delegations within the Budget and Police Framework' on 15 September 2020, Minute 44 refers.
