1.0 Report

It has been recently reported that there are two fly-grazed mares on city council owned land east of Middleton Road, Middleton. There are no grazing agreements in place on this land so the horses are being illegally grazed. The animals are not chipped and therefore we are unable to trace their owner. However similar problems have occurred in the past and local intelligence has led us to believe who the owner may be.

The Council has written to that individual requesting that if the animals belong to him then he should remove them immediately, but he has failed to do so.

Once the Council has attempted to locate the owner and persuade them to remove the horses it can look at detaining and disposing (relocating) the horses. Therefore, the next step is to issue and fix to the site legal notices under the Animal Act 1971 (as amended by the Control of Horses Act 2015). After 96 hours of the notices being served the animals can be relocated.

Unfortunately, the issuing of such notices under the Animal Act 1971 (as amended by the Control of Horses Act 2015) is not included in the Council's Constitution or delegated to officers, therefore an ICMD from the cabinet member portfolio holder for Asset and Property Management is required to authorise the issuing of these notices.

4.0 Options and Options Analysis (including risk assessment)

Option 1:

Proceed with the issuing of legal notices so the horses can be removed from site.

Advantages:

Whilst there is no indication that the horses have been totally abandoned, one of the mares is heavily pregnant. They need to be removed to a better and safer location. The land can then be secured and regularly inspected.

Disadvantages:

None.

Risks:

None.

Option 2:

Do not proceed and the horses remain on site.

Advantages:

None.

The animals will have to be removed at some stage.

Disadvantages:

As landowners, the Council has a duty of care for these horses' welfare. It has neither the in-house resources nor knowledge to care for these animals.

Risks:

This would lead to a lost opportunity to get the animals removed from site and relocated to a horse and foal sanctuary.

The council is continuing to receive phone calls from concerned members of the public about the condition and location of these animals.

4. Officer Preferred Option (and comments)

4.1 The officer preferred option is Option 1. To proceed with the issuing of legal notices so the horses can be removed from site.
