That the contract for Air Source Heat Pumps be awarded to Ivegata Ltd.	
Reasons for the decision:	
<p>On 23rd March 2021 Cabinet provided delegated authority to the Chief Executive to award contracts linked to the PSDS project when a decision was ready to be made: (Decision to Award Contract – Solar Scheme SALC – Minute 128 refers).</p> <p>A Mini competition was completed by officers and the council’s procurement and energy management consultants, through The Chest portal. Seven pre-qualified suppliers were invited to tender.</p> <p>Ivegata Renewable Energy provided the most comprehensive return and scored the highest out of the three compliant submissions. The cost of the contract is wholly covered by the Public Sector Decarbonisation Scheme funding and falls within the estimated budget for the work.</p>
