Details of Decision: Award of contract to North West Solar					
 Reasons for the decision: On 23rd March 2021 Cabinet provided delegated authority to the Chief Executive to award contracts linked to the PSDS project when a decision is ready to be made: Item No. 128 Decision to Award Contract – Solar Scheme SALC refers. Officers completed a detailed ITT with external consultants and legal advice and completed a mini competition using the Public Power Solutions Framework. Two responses were received. After meeting both bidders and completing comprehensive questions and clarifications process this resulted in only one of the bids being compliant, meeting all essential criteria. Officers intend to award the contract for ground-mounted solar PV to North West Solar, Lancaster. The contract value falls under the budgeted amount allocated and is estimated to generate £99,575 worth of social value.
