Vehicle Operation - May 2023

Thursday 8th June 2023

Report of Licensing Officer

PURPOSE OF REPORT

To inform the committee of the outcome from the recent unannounced checks carried out jointly with Licensing Enforcement Officers and DVSA on Licensed Hackney Carriages and Private Hire vehicles operating in Lancaster and Morecambe.

This report is public.

RECOMMENDATIONS

1. The Committee is asked to note the outcome of the operation.

1.0 Introduction

- 1.1 The undertaking of vehicle compliance and safety checks on licenced Hackney Carriage and Private Hire Vehicles is conducted from time to time, usually as a joint initiative with other agencies. The purpose of the checks is to determine whether the vehicle complies with the Councils standards for licensed vehicles and to assess road worthiness.
- 1.2 For the checks conducted on the 3rd May 2023 it was decided that no notice period would be given and therefore all vehicle inspections were carried out unannounced.

2.0 Purpose and extent of the vehicle checks

2.1 The operation was conducted in partnership with DVSA. The drivers of the vehicles were instructed on the day by Private Hire Operators, the Licensing Admin Team and Police Officers to attend the inspections carried out on the rear carpark of Morecambe Town Hall. Initially we planned to host the vehicle operation at Salt Ayre in Lancaster which is a central location. However, Salt Ayre have become busier since the previous vehicle operation was conducted and therefore our operation may have caused issues with customer parking.

Photographs of the layout of the Vehicle Operation at Morecambe Town Hall can be seen at Appendix 1 of the report.

- 2.2 The Licensing Officers carried out checks to assess compliance with the appropriate Council standards for licensed vehicles whilst the DVSA inspectors focussed on the mechanical roadworthiness of vehicles.
- 2.3 All vehicles that were either not operating on the day or due to time constraint could not attend are to be followed up and subject to inspection in the coming weeks.

3.0 Summary outcome

3.1 Summary of the main outcome from the operation.

Summary inspection results

- 83 individual vehicle inspections were carried out
- 30 Hackney Carriages and 53 Private Hire Vehicles checked
- Licensing staff issued 11 defect notices & 3 suspension notices
- DVSA issued 3 prohibition notices.

The majority of defects issued were in relation to the poor condition of door signs, expired fire extinguishers and damage to vehicle body work. A handful of vehicles were suspended due to more serious defects including illegal tyres. DVSA issued 3 x prohibition notices due to tyres being below the legal limit and an indicator not working.

At the time of writing this report of the 11 defect notices issued, only 3 defects are outstanding, and all suspensions have been lifted.

4.0 Feedback

- 4.1 Licensing Officers have received feedback from the DVSA Officer in attendance during the multiagency vehicle operation. The feedback from the DVSA Officer can be located at Appendix 2 of the report.
- 4.2 Licensing Officers requested feedback from a handful of licensed drivers in attendance on the day of the Vehicle Operation. The feedback received from the licensed drivers can be located at Appendix 3 of the report.

5.0 Conclusions

5.1 Licensing Officers and DVSA felt that by conducting the operation without prior notice to the trade provides more realistic results and contrary to what may be expected, significant complaints were not received from licensed drivers or operators at the time of the operation or in the days that followed. It was felt that had notice been given, the more serious defects such as illegal tyres, would not have been found.

- 4.2 It has been recognised by Officers that the next Vehicle Operation that is planned needs to be in a Central location to increase the number of inspections that are carried out on the day.
- 4.3 In addition to the vehicle operation that has been carried out, Licensing Officers are planning to carry out an operation for Private Hire Operators. This will involve Operators attending Morecambe Town Hall and presenting their operator records as required by their licence conditions. Officers will take this opportunity to provide supporting documents and advice/guidance to Operators that will assist them in being compliant. The outcome of the Operator Operation will be presented to Members within the Annual report in April 2024.

Re Taxi operation 03 May 2023.

Overall, I thought that it was a well run and organised operation. The nice weather and staff helped. The location was not as originally planned and therefore I felt that it did have a negative effect on the operation. A central location would have probably meant more vehicles being inspected, although I think we did a pretty good job with the number of taxis that came.

The first 2 taxis inspected were issued with immediate prohibition notices. One had a tyre below the legal limit and the other a 19-plate taxi had 2 illegal front tyres.

A third taxi was issued with an immediate prohibition notice for an indicator not working.

It was a benefit only letting the taxi operator know that we were holding a check on the day. However, as the day went on, I did notice a significant number of taxis coming in that had had new tyres fitted.

The lack of Police presence probably had a negative effect as they can often pick up those reluctant to be inspected.

Licensing Fees and Charges 2023/24 – Consultation Responses

PURPOSE OF REPORT

The purpose of the report is for members of Licensing Committee to consider consultation responses regarding proposed licensing fees and charges, and set animal, miscellaneous and hackney carriage/private hire licensing fees and charges for 2023/24.

This report is public.

RECOMMENDATIONS

- (1) Members are requested to consider the responses received as part of the public consultation, and;
- (2) Set fees and charges for taxi/private hire licensing, animal related licences and all other miscellaneous licences administered by the licensing function of the Council. (Eg. Scrap metal/Tattoo/Street Cafes/Second hand dealers/SEVs).
- 1.0 Introduction
- 1.1 This report is concerned with the setting of licence fees for the following licences.
 - Driver, Vehicle and Operator Licences (Taxi and Private Hire)
 - Transfer of Ownership and Change of Vehicle Licences
 - Scrap Metal Dealers (Mobile and Site)
 - Street Cafes
 - Skin Piercing Registration (Personal and Premises)
 - Sexual Entertainment Venues
 - Sex Shops
 - Boatman and Pleasure boats
 - Second-hand goods dealer/Market trader
 - Animal-related licences

The setting of such fees is a non-executive function and is therefore a matter for this Committee.

- 1.2 Licensing fees for taxi/private hire, animal and miscellaneous licensing are considered and set under the following legislation.
 - Local Government Miscellaneous Provision Act 1976

- Local Government Miscellaneous Provision Act 1982
- Scrap Metal Dealers Act 2013
- Highways Act 1980
- County of Lancashire Act 1984
- Public Health Acts amended Act 1907
- The Animal Welfare (Licensing of Activities Involving Animals) (England) Regulations 2018

2.0 Background

- 2.1 The Council's Fees & Charges Policy states that when setting discretionary charges, the general aim is to cover the cost of the service, accurately reflecting the full cost of provision including recharges. However, fees must be reasonable and proportionate. The fees and charges policy in relation to licensing fees offers a standard of good practice, although it is not legally binding on Licensing Committee.
- 2.2 It is also a requirement of the Council's fees & charges policy that fees be reviewed annually to ensure that costs are appropriately recovered. It is not lawful however, for the council to seek to make a profit from licence fees that are within its discretion.
- 2.3 Licensing fees have remained consistent with those set in 2019, when a full review of the service fees and charges were determined by the then, Licensing Regulatory Committee. The coronavirus pandemic followed in March 2020, during this time and to assist business recovery, fees set by Lancaster City Council were frozen, therefore no review of licensing fees and charges has been undertaken since 2019.
- 2.4 A full and detailed review of the current fee-setting framework has been undertaken by the Licensing Manager and Service Finance Officer. Including, time monitoring exercises, scrutiny of previous year(s) data and analysis of potential anomalies in projected figures and subsequent income.
- 2.5 Updated fees reflecting the review were proposed and considered by Licensing Committee in March 2023.

It was agreed "That licensing and miscellaneous licence fees would be increased, not by the recommended amount, but by 20% (to the nearest pound) now; and to affect a further increase in the following year with a view to achieving full cost recovery in 24/25, accepting that the fee increases may again be above inflation. The reason for the twostage increase is to smooth the impact on the trade." and

"That the Committee approve the new licensing fees for animal-related licences as detailed in the review". (full cost recovery)

2.6 The proposed fees were advertised as required by s70 of Local Government Miscellaneous Provisions Act 1976 as part of a public and trade consultation. For completeness/transparency of process all fees subject to change were advertised as part of the consultation.

The advert was placed in the Lancaster Guardian, at both Morecambe and Lancaster Town Hall, Lancaster City Council website, additionally members of the licensed trade were invited to make comments on the proposed fees.

A copy of the consultation advert is attached at **Appendix 1**.

3.0 Consultation Responses

3.1 During the consultation period 10 responses were received, all from licensed hackney carriage or private hire drivers/operators. Each response raised an objection to the proposed increase in licensing fees.

Consultation responses are attached at Appendix 2.

- 3.2 In summary, those raising an objection to the fee increase felt that increasing the fees by 20% was too much and that it would have a negative impact on the licensed trade. Currently, there is a shortage of licensed drivers, increasing fees would further exacerbate the issue. Further comments are noted regarding poor levels of service and problems in contacting the licensing service.
- 3.3 No responses to the consultation were received from any miscellaneous, animal related licence holder or any other persons.

4.0 Options

The options available to members are twofold:

- i. To set fees and charges to allow for full cost recovery as proposed by the Animal Licensing Manager and Finance Officer for animal related licences.
- ii. Increase miscellaneous/taxi related fees by 20% as proposed, set out in **Appendix 1**, with a view to achieving full cost recovery by 2024/25.
- iii. Upon consideration of the consultation responses, members may wish to amend/maintain any licence fee as appropriate.

6.0 Conclusion

- 6.1 Licensing fees have been frozen since 2019/20, current fees and charges do not reflect the cost of running the licensing service. If current fees are maintained, the service would continue to run at a significant loss. The review and proposed increase in fees are necessary to balance the budget and cost of service delivery by 2024/25.
- 6.2 It is important to acknowledge the consultation responses and concerns of the those making representation. It has been widely reported that numbers of drivers both locally are nationally have reduced significantly, it is part of the licensing workplan for 2023/24 to increase driver numbers and work with internal/external partners to promote the profession. Furthermore, the private hire and hackney carriage licensing policy (adopted by this committee in April 2022) will be reviewed in the coming months, application standards will be reviewed as part of this process.
- 6.3 It is suggested by those making representation that the proposed fees do not represent the level of service expected by licence holders. It is important to highlight that the licensing service is not solely funded by taxi/PH and miscellaneous licence fees, the scope is wide and the workload ever increasing. Licence fees are set on a cost recovery basis, with the fee payable accounted for the time taken to process and administer each individual licence.

6.4 Members are requested to provide full and detailed reasons for their decision.

Licensing fees have been frozen since 2019/20, The volume of licences also dropped over that period, but costs have continued to rise, consequently the Licensing function has been running at an average deficit of circa £80K pa over the period 2020/21 to 2022/23. It is not proposed to seek to recover the losses from previous years but set fees with a view to achieving full cost recovery. At present the fees for Licensing Act 2003 and Gambling Act 2005 are set nationally so we are unable to recover any potential losses on these. The fee income for the current year will be reviewed as part of the closure of accounts and the Council's usual monitoring arrangements with any significant variances being reported as appropriate.



Report of the Licensing Manager

PURPOSE OF REPORT

The taxi and private hire working group, a recognised group tasked with addressing issuing affecting the local trade requires further membership following changes with appointments to Licensing Committee.

This report is public.

Recommendations.

- (1) That the Committee appoint at least three members of Licensing Committee to attend and contribute to the taxi working party.
- (2) The chair of Licensing Committee has historically attended and chaired the taxi working party meetings.

Report

- 1.1 It was approved at a meeting of the former Licensing Regulatory Committee on 31st August 2017 to establish a taxi and private hire working party.
- 1.2 The taxi and private hire working group was designed to bring together individuals, including elected members, stakeholders and Council Officers who possess the relevant knowledge and skills of the subject area, who will act collectively to undertake assigned tasks and activities to achieve the project's objectives; in this case ensuring the continued review, development and improvement of the Councils taxi and private hire services.
- 1.3 The make-up of the taxi working party was agreed as follows.
 - At least 3 Councillors (including Chair of Licensing Committee)
 - Licensing Manager
 - Licensing Enforcement Officer(s)
 - 1 x Private Hire representatives
 - 1 x Hackney Carriage representatives
- 1.5 Due to limited numbers of the licensed trade expressing an interest in representing the trade /contributing to the meeting, it was agreed that all those expressing an interest could attend. It included 1 private hire operator, 4 licensed drivers (private hire and hackney carriage).
- 1.6 All those previously attending will be invited to contribute, furthermore expressions of interests will be sought for appointed representatives of the licensed trade. It is important that the views of the majority are considered when discussing matters

affecting the local trade. It imperative that members know what weight to place on the views of those attending.
