- (2) Cabinet approves the steps/measures supporting sustainable food places as outlined at paragraphs 2.1 (b) to (e) of this report.

1.0 Introduction

- 1.1 The Sustainable Food Places Award is a national, evidence-based recognition and celebration of places taking a joined-up, holistic approach to sustainable and healthy food. Awardees have to demonstrate activity and impact across their food system by the food partnership and wider stakeholders to create a local 'Good Food Movement'.
- 1.2 The level of activity expected increases from Bronze, to Silver and then Gold, with the expectation that Gold awardees are innovating and supporting food system-wide transformations in their place at a level that is pioneering and of interest to an international audience
- 1.3 The North Lancashire region gained the Silver accreditation in autumn 2023 and highlights the Food Futures strategic ambitions.
- 1.4 Following a partnership-wide decision in Spring 2024, the Food Justice Partnership, which consists of partner organisations including food clubs, foodbanks, Citizen's Advice, Lancaster CVS, NHS and Lancaster City Council, agreed to facilitate a two-year process to support North Lancashire in

working towards a Gold Sustainable Food Places Award, with the aim to submit a Gold application in 2026

2.0 Proposal Details

2.1 It is proposed that the Council:

- a. officially and publicly supports the North Lancashire Sustainable Food Places Gold Award application. That this is supported officially through communications that highlight both how existing projects and work support the gold award and the Council Plan and values
- b. continues supporting the Food Futures partnership through attending key strategy and working group meetings and feeding into key strategic projects that are aligned with the Council's priorities e.g. community composting approaches, Lancaster District's food ladders approach, taking forward allotment review recommendations.
- c. Continues to support use of the White Lund Depot Nursery, with the potential to extend provision where possible, so that the partnership can continue to build its resilience and ability to host the Lancaster Districts FarmStart scheme. This initiative supports training in organic horticulture, supports new entrants into growing, will be hosting "Growing food and community training" in partnership with other local food projects over the next two years, and is supporting the set of other agroecological sites around the District, including a new community farm. Its strategically aligned with a number of the Council's own priority areas.
- d. Feeds into District Food Justice Partnership strategies, which is aimed at tackling food poverty, diet related ill health and access to affordable healthy food, to build resilience post Holiday Activities and Food (HAF) funding.
- e. Reviews council procurement practices in light of the Food Futures community food strategy and the Good Food Manifesto and work to increase procurement of sustainable local produce and reduce food waste from council outlets. As part of this it could consider procuring through Gather: Lancaster District's pilot local food hub that brings together a range of local sustainable food producers and makes it easier for individuals and retailers to source local produce. For example, could the Printroom feature a seasonal Gather? salad throughout the year?
- f, Support meaningful engagement from Anchor Bay Institutions, with movement towards adopting more sustainable food procurement policies and practices and increasing community land use for sustainable food production.
