| | Whilst Lancashire County Council is responsible for the preparation of the strategy Lancaster City Council is identified as a supporting authority, responsible for assisting the County Council in identifying local priorities and importantly in providing approval of the strategy for wider consultation at its draft stage and again prior to its publication. | |
| | The regulations state that the supporting authorities will be given 28 days to grant this approval. In view of the limited time for approval it is requested that the respective decisions are delegated to the Chief Officer of Planning and Climate Change to approve the LNRS on behalf of the Council. This Cabinet report seeks to secure the process for these approvals through a Recommendation of the Portfolio Holder. | |
