That Gillespies LLP be appointed to prepare public realm design proposals for the Lancaster Square Routes Project.

Reasons for the decision (continue on separate sheet or append relevant papers as necessary):

Close alignment of the regional, NWDA and Council policy positions now makes prospects for bringing forward and delivering public realm improvement projects in the city centre very much more encouraging. NWDA and Lancashire County Council have made available funding for the City Council to prepare to a detailed design stage a series of projects to upgrade public spaces in the city.

The council has tendered for this work. It is recommended that the Council appoint Gillespies LLP to produce design proposals as set out in the Lancaster Square Routes Tender Brief.
