# **RECOMMENDATIONS**

(1) That Councillor Janice Hanson, as the Portfolio Holder for Economic Regeneration, be appointed to the Lancaster BID Management Group.

## 1.0 Introduction

- 1.1 At its meeting on 27 February 2013, Council considered a report to decide the basis of appointment to the Lancaster BID Management Group.
- 1.2 It was noted that Councillor Hanson, as Cabinet Member for Economic Regeneration, had been appointed by Cabinet to the BID Steering Group in July 2011 and that a new representative Management Group of local business/stakeholders was being recruited to oversee the delivery of projects and provide strategic overview of the Lancaster Unlimited BID initiative and its management arrangements. There was one seat on the Group for a Member to represent Lancaster City Council as a BID levy payer and key stakeholder and Council was asked to decide the basis of the appointment to that seat.

## 2.0 Proposal Details

- 2.1 Council resolved that the appointment be on the basis of appropriate Cabinet Member and the matter has therefore been referred to Cabinet to make that appointment at this meeting.
- 2.2 Council also resolved to ask the BID if they would agree to invite the appropriate Ward Councillor to also sit on the Management Group. That request has been made and a response is awaited.

#### 3.0 Conclusion

3.1 Cabinet is therefore asked, in line with the wishes of Council, to appoint the portfolio holder for Economic Regeneration to the Lancaster BID Management Group.
