I am in receipt of your application for the above premises.

I have reviewed the application and I believe that the following conditions need to be added to the application to ensure that the Licensing Act objectives are upheld:

CRIME AND DISORDER LICENSING OBJECTIVE

CCTV equipment shall be installed and shall be maintained in good working order in accordance with the manufacturer's instructions. Training should be provided for staff members in the usage of the CCTV equipment. CCTV footage recorded must, as a minimum, cover each entry/exit point of the premises and be recording at all times when the premises is conducting licensable activities.

The images recorded by the CCTV system shall be retained in unedited form for a period of not less than 31 days.

The Data Controller will make footage available within a reasonable time to a Police Constable or Authorised Officer, where such request is made in accordance with and which satisfies the Data Protection Act 1998.

The above will be in addition to the mandatory conditions of premise licence and also any other condition requested by any other responsible authority.
