PURPOSE OF REPORT

1 Introduction

- 1.1 The council has a number of contracts with VCFS partners, as part of commissioning arrangements for the delivery of advice and information services, infrastructure support and volunteering.
- 1.2 These contracts were the result of a procurement exercise undertaken in 2012 for the provision of services outlined in the Delivery and Commissioning Plan approved by Cabinet in December 2012.
- 1.3 Successful partners formally entered into a contract with the council for the financial year 2013 with the option of adding 2014/15 and 2015/16 subject to the budgetary process.
- 1.4 At its meeting in March 2013, Cabinet approved the distribution of funds totalling £245,000 for the delivery of these services.

2 Details

2.1 Appendix A provides a review of activity for the delivery of advice and information services, infrastructure support and volunteering. The report sets out the achievements, concerns and progress made for the period April 2013 to December 2014 by each commissioned partner, and identifies how they contribute towards the delivery of priorities in the 2014 – 16 Corporate Plan.

3 Conclusion

3.1 The commissioning approach undertaken by the Council has been well received and generally viewed as a significant improvement in the allocation of

- funding to successful partners for the delivery of advice and information services, infrastructure support and volunteering.
- 3.2 Overall the report shows that partners have performed reasonably well, with some notable achievements in very challenging circumstances and at a time of changing individual needs and dynamics within the VCFS sector.
