- 1. Apologies for absence were received from Cllr Jackson-Pitt and City Cllr Mace.
- 2. Minutes of the meeting held on Monday 3rd July were read, agreed by Cllrs and signed as a true record by Cllr Howarth and seconded by Cllr Chris Preston.
