## Whittington Parish Council

15 minutes of hearing parishioner's concerns prior to the start of the meeting was attended by 4 members of the public.

The proposed increase in bus service from 5<sup>th</sup> March 2018 was discussed. Stagecoach and Kirkby Lonsdale Coaches are putting on a further 13 buses through the village. Parishioners are encouraged to use the buses as the service will be reviewed in 4 years. Information about NOW bus passes are available on John Keegan's village blog. Reduction of speed through the village was discussed, the Clerk informed members that Allan Cox, Speed Management Team, Lancashire County Council, has not been in touch regarding enquiry into traffic calming measures. Crime reports from Lancashire Constabulary come too late to be of any use eg: October and November's reports are on January's agenda. A parishioner had not yet had a reply to an Email sent in November, items for discussion included SpID, mis-recording of discussions in meetings and availability of Annual Parish Assembly minutes from 8<sup>th</sup> May 2017. Clerk apologised and would rectify this. A parishioner noted that Standing Orders are not a requirement for a Parish Council to adopt.

Cllr Hall reported that 1 parishioner had volunteered to undertake the training for use of the AED defibrillator. 3 villagers are also cogniscent with the apparatus and prepared to hold weekly training sessions once it has been installed. Whittington Village Hall agreed to site the storage box, with associated electrical access, on the external wall, front elevation of the hall and adjacent to the main entrance, between the noticeboard and the porch; and agreed to donate funds along with the Parish Council. An application for 50% funding from British Heart Foundation will be made for the recommended device Zoll AED Plus Defib at £1,137.60

Cllr Lawson tendered his resignation as from after the meeting on 19<sup>th</sup> March 2018.

City Cllr Williamson notified the members of a Parish Review with a deadline date of 31<sup>st</sup> January 2018.
