<b>Details of Decision:</b>  That Bamber's Remedial Contractors Limited be awarded the contract for 14 Altham Walk Conversion of Houses to Flats as specified in the tender documentation advertised using the CHEST portal.			
<b>Reasons for the decision:</b>  The tenderer that returned the lowest price did not include a quality evaluation submission in their tender and also did not include the significant contingency sum required by the tender documentation. The pricing of the works were also significantly less than expected and in comparison to other contractors. This has therefore been categorised as a non-compliant tender.  Tenders for the works have been received via the CHEST portal and Bamber's Remedial Contractors submitted the lowest compliant tender price and a good quality evaluation submission. The budget allocated to this project overall is £75,000 and the tender price put forward for acceptance should mean that the overall cost to this budget will be below the estimated budget figure.
