To proceed with implementation of the City Councils Fleet Replacement Programme for 2021-2022			
<b>Reasons for the decision:</b>			
Council 24 <sup>th</sup> February 2021 approved the Capital Fleet Replacement Programme 2021-2022, for a value of £3.084m ( <i>minute 115(1) refers</i> ).			
Tenders for the procurement of these various vehicles has already been conducted and processed through the YPO Framework and are in line with the agreed budget.			
<b>IS THE DECISION URGENT NO, BUT</b>			
Any further delays will add pressure onto the revenue account. Current operational vehicles are experiencing high repair costs, and in some circumstances, a hire vehicle is required to ensure high operational standards are still achieved.			
I can confirm that this decision is urgent as any delay likely to be caused by the Call-in process would seriously prejudice the Council's or the public's interests and therefore is not subject to Call-in. The Chair of the Overview and Scrutiny Committee has been consulted.
