<ol style="list-style-type: none"> <li>1. <b>Endorsement of the proposed changes to the Neighbourhood Plan, as set out in the Examiners Report and agree that decision statement can be issued to inform interested parties that the modified Neighbourhood Plan should proceed to Referendum as soon as reasonably possible.</b></li>   <li>2. <b>Agree to the advance funding of the Referendum which will be claimed back from the Government in due course.</b></li> </ol>	
<b>Reasons for the decision:</b>	
<p>Proceeding with the referendum would be to the benefit of adopting localism within the district, enabling communities to shape their area. It would enable the community as a whole to decide if the plan should be sued by the Council for determining planning applications.</p> <p>Given the level of work undertaken by the Parish council alongside the extensive consultation that took place prior to the Examination of the plan it is considered that subject to the outcome of the referendum that it is the will of the community of the Parish of Aldcliffe with Stodday for a neighbourhood plan to be adopted.</p> <p>The independent Examiner has scrutinised plan in making an assessment as to whether it meets the Basic Conditions and subject to modification is of the view that the plan is ready to proceed to Referendum.</p> <p>In conclusion, the Aldcliffe with Stodday Neighbourhood Plan is ready to proceed to referendum, subject to modifications as recommended by the Examiner being made.</p>
