PURPOSE OF REPORT

To enable members to determine an application for a Premise Licence under Section 17 of the Licensing Act 2003 submitted by Wennington Hall Limited, Station House, Station Road, Whalley, Clitheroe, BB7 9RT, following the receipt of a relevant representation.

RECOMMENDATIONS

The Sub Committee is requested to determine in the light of the representations made and having regard to the Council's Statement of Licensing Policy, The Licensing Act 2003 and any Regulations made under that Act as well as Government Guidance whether to grant the application as requested, modify any conditions of the licence, or to reject the whole application. Members are reminded that they should state the reasons for their decision.

1.0 Introduction

1.1 The Council grants permissions for Premise Licences submitted under the Licensing Act 2003 (the Act). Wennington Hall Limited have submitted an application under Section 17 of the Licensing Act 2003 for the grant of a premises licence in respect of Wennington Hall, Lodge Lane, Wennington, Lancaster, LA2 8NS.

The application is for a licence to facilitate the following:

Provision of Plays & Films Monday – Sunday 10:00 until 02:00

Regulated Entertainment Monday – Sunday 10:00 until 02:00

(Provision of Live & Recorded Music and Performance of Dance)

Late Night Refreshment Monday – Sunday 23:00 until 02:00

Sale & Supply of Alcohol Monday – Sunday 00:00 until 23:59 (Residents)

Monday – Sunday 10:00 until 02:00 (Non-Residents)

Details of the application for the premises licence are set out in the application form including the plan, which is detailed as No.1 to this report.

- 1.2 There is a statutory requirement to advertise such applications for a period of 28 days in which time representations in favour or against the application can be submitted. Any representation submitted must relate to the likely impact of the grant of the licence on one or more of the four licensing objectives which are:
 - The prevention of crime and disorder
 - o Public safety
 - o The prevention of public nuisance
 - The protection of children from harm
- 1.3 During the statutory 28 day consultation period the Council received one relevant representation from "Other Persons" as defined by The Act. This relates to the Public Nuisance licensing objective.

Details of the representation are attached at Appendix No.2.to this report.

- 1.4 The concerns of The Other Persons relate predominantly to public nuisance where it is perceived that should Members seek to grant this licence then there would be strong likelihood of an increase to noise nuisance in respect of neighbouring residential premises. Further, they believe that to allow licensable activities to continue until 02:00 hours would have a detrimental impact on the naturally quiet ambience in the hamlet of Wennington as a whole and that midnight is sufficiently realistic concluding time for such a wedding and conference venue.
- 1.5 Any representations must relate to the likely impact of the grant of the licence in relation to all four of the licensing objectives, namely:
 - Public Safety
 - o The prevention of crime and disorder
 - o Public Nuisance
 - The protection of children from harm
- 1.6 Under Section 18(3) of the Act, it is necessary for a hearing to be held to consider the application, as representations have been received from Responsible Authorities. The relevant section prescribes:

Where relevant representations are made, the authority must-

 (a) hold a hearing to consider them, unless the authority, the applicant and each person who has made such representations agree that a hearing is unnecessary, and (b) having regard to the representations, take such of the steps mentioned in subsection (4) (if any) as it considers appropriate for the promotion of the licensing objectives.

The steps Members may take are-

- (a) to grant the licence subject to -
 - the conditions mentioned in subsection 2 (a) modified to such extent as the authority considers appropriate for the promotion of the licensing objectives and
 - (ii) any condition which must under section 19,20 or 21 be included in the licence.
- (b) to exclude from the scope of the licence any of the licensable activities to which the application relates
- (c) to refuse to specify a person in the licence as the premises supervisor.
- (d) to reject the application
- 1.7 The updated Council's Statement of Licensing Policy was approved by Licensing Committee in November 2023 and will subsequently be considered by Cabinet in February 2024, prior to approval by Full Council. We can however rely on the previous policy until full implementation of the updated version.

This is attached at Appendix No.3 to this report. The following sections are relevant to this application:

- 1.8 In accordance with the relevant Regulations, the parties have been given notice of the hearing. The parties have been required in accordance with the Regulations to indicate at least five working days before the hearing whether they intend to attend and/or be represented at the hearing and if they wish any witness to appear at the hearing. Any responses and any further documentation submitted by any of the parties after the circulation of this agenda will be circulated to Members in advance of the meeting. Members are reminded that documentary or other information submitted on the day of the hearing may only be taken into account with the consent of the Sub-Committee and all the parties.
- 1.9 Members are reminded that they must follow the rules of natural justice and must also consider human rights implications. In particular, in accordance with Article 6, all parties are entitled to a fair hearing. Consideration also needs to be given to the right to respect for private and family life and home, contained within Article 8, although this is a qualified right, and interference is permitted where this is in accordance with

the law, or is necessary in a democratic society in the interests of public safety or the prevention of crime and disorder, or for the protection of the rights and freedoms of others. Article 1 of the First Protocol provides that every person is entitled to the peaceful enjoyment of his possessions, although again this right is qualified in the public interest.

2.0 Conclusion

2.1 Members should consider, having regard to the Councils Statement of Licensing Policy, The Licensing Act 2003 and any Regulations made under that Act, Government Guidance and representations made, whether to grant the application as requested, modify any conditions of the licence, or to reject the whole application. Members are reminded that they should state the reasons for their decision.
