### 6 **Noticeboard:**

Cllr Dinsdale reported that the noticeboard on the village green is in need of maintenance; the doors will not open/shut properly, the handle is too small, the pinboard is damp and distorted and the case needs cleaning and re-varnishing. It was resolved to contact a joiner to quote for repairs.

# 7 Queen's Green Canopy:

Cllr Dinsdale reported that the newly planted Holm Oak has done well through the winter. There is still no further news on a plaque but slate and brass options are available. Cllr Dinsdale will look online for a suitable plaque. Cllr Huddleston also agreed to arrange for the plaque in memory of Tom Metcalf to be attached to the new bench.

# 8 **Meeting dates:**

It was decided not to hold a meeting in March. The next meeting will therefore be held on 3 April with the Annual Parish Meeting to be held on 15 May after the elections on 4 May. The period of 'purdah' will be 20 March to 4 May (10pm). It was resolved to arrange the meetings for the rest of the year at the May meeting.

## 9 **PACT report:**

In December 2022 there were 6 crimes reported in the Kellet/Borwick constabulary area. There was one case classified as 'other theft' on or near Meadoway and one case of burglary on or near the Sheiling. The remaining crimes were in Over Kellet and Nether Kellet and also one of criminal damage/arson on Addington Road.

### 10 Additional business:

- Cllr Huddleston reported that preparations for a lunch to celebrate the Coronation were going ahead and the village hall has been booked. It was proposed by Cllr Huddleston to form a sub-committee to help organise the event, with parish council support, and this was agreed by all present.
- The Hopewell Cup will be judged on the theme of hanging baskets this year; the Clerk will send out a reminder soon.
- A replacement plug/extension for the Christmas tree needs to be ordered from Xmas Direct. Cllr Howarth has managed to lock the pillar feed to prevent people from messing around with it.
- The Clerk will need to order a new minute book early this year which may be in the region of £75 or more.
