<p>Lancaster City Council's UKSPF Investment Plan sets out its plan for delivering the Lancaster district's £5.3m UKSPF allocation from 2022-25. The Investment Plan was agreed by government in December 2022.</p> <p>Implementing the UKSPF programme requires the council to allocate funds to a range of projects which will deliver on the outcomes and outputs set out in the Investment Plan. This allocation in respect of Interventions relating to Community and Place will enable the project to commence delivery and begin creating positive local impact.</p>
