To put restrictions on certain types of behaviour that impacts on the quality of certain public spaces in defined locations in Lancaster District.

Who is intended to benefit? Who will it have a detrimental effect on and how?

Residents, visitors and local businesses have reported concerns about levels of anti-social behaviour (both related to the consumption of alcohol and youth related) that mean they do not feel safe in a certain locality, or the business has been impacted by prople avoiding certain areas due to the behaviour of a minority of people that continue to ignore the PSPO (Public Space Protection Order) that was introduced in December 2021. The restrictions in the PSPO are designed to have the least detrimental affect - the action needs to be accompnaied by an act of anti-social behaviour. For example the prohibition of alcohol clause has to be accompained by behavour that is of a nuisance or annoyance.
