I am writing to formally object to the application for an off-licence at the petrol station located at bowling green service station BP. I am a local resident living nearby, and I have serious concerns about the negative impact this proposal would have on both road safety and the surrounding community.

The petrol station is situated in close proximity to a major motorway entrance. A significant number of customers who use this site proceed directly onto the motorway after refuelling. Allowing alcohol sales at this location poses a substantial risk of encouraging drink driving or contributing to impaired driving incidents. The sale of alcohol in such a setting undermines public safety and contradicts the responsibility that should be upheld by a business operating so close to a major road network.

Subject: Objection to the Application for an Alcohol Licence – Bowling Green Service Station, Scotforth Road, Lancaster, LA1 4SG

I am writing to formally object to the application for an alcohol licence submitted by the Bowling Green Service Station, located on Scotforth Road, Lancaster, LA1 4SG.

My objection is based on several concerns relating to public safety, crime and disorder, and the protection of children from harm.

Firstly, the premises adjoining the Bowling Green Service Station is due to become a PadelX sports facility, which will attract families, young people, and children to the immediate area. The sale of alcohol in such close proximity to a sporting and recreational facility is, in my view, inappropriate and poses potential risks to the welfare of young people.

Secondly, permitting the sale of alcohol at this location could lead to an increase in incidents of shoplifting and underage individuals attempting to solicit alcohol purchases from other customers using the service station. This may, in turn, contribute to antisocial behaviour, including groups congregating around the premises and the potential on-site consumption of alcohol.

Furthermore, the geographical area surrounding the Bowling Green Service Station already contains several licensed premises, including a public house, a Bargain Booze store, and a Booths supermarket — all within approximately 200 metres. Given this, I see no justification for an additional alcohol outlet at a petrol station.

I am also concerned that the sale of alcohol from a service station may indirectly encourage drink-driving. The nature of the business means that the majority of customers will be motorists, and the availability of alcohol at a petrol station may increase the risk of individuals consuming alcohol either prior to or during driving, with potentially serious or even fatal consequences.

In addition, there are inherent safety concerns associated with selling alcohol at a petrol station. If an individual under the influence of alcohol were to visit the site —

particularly late at night — the risks associated with fuel, smoking, or reckless behaviour could be greatly amplified.

It is also worth noting that, from my personal observations, employees at the Bowling Green Service Station frequently work alone. Introducing alcohol sales could place additional pressure on lone workers, increasing both safety and security risks.

For these reasons, I strongly believe that granting this licence would not serve the interests of public safety, the prevention of crime and disorder, or the protection of children from harm. Considering the proximity of existing alcohol retailers and the potential hazards outlined above, I respectfully urge the Licensing Authority to refuse this application.

I am writing to formally object to the alcohol license application for Bowling Green Service Station. I have several serious concerns regarding the potential risks and negative impact this could have on the local area and community.

Firstly, the building next door is due to become a PadelX court, which will attract younger people and families to the area. Allowing alcohol sales so close to a venue that draws in young people creates a high risk of antisocial behaviour and crime. There is also a significant concern around proxy sale attempts — where underage individuals ask adults to purchase alcohol on their behalf. This problem is common in mixed-use areas and would place additional strain on staff and the local community. Furthermore, the presence of alcohol could encourage groups of young people to loiter around the service station, increasing the risk of disorder and on-site consumption.

Secondly, the immediate geographical area is already saturated with licensed premises — including a pub, Bargain Booze, and Booths — all within approximately 200 metres. There is no legitimate need for another outlet selling alcohol. Granting a license to a petrol station also increases the risk of drink driving. The combination of alcohol sales, motor vehicles, and fuel creates a serious and unnecessary safety hazard; it only takes one impaired or careless driver to cause a dangerous incident.

Finally, staff at the service station frequently work alone. Managing alcohol sales would add extra pressure and potential conflict, particularly when refusing sales or dealing with intoxicated or underage individuals. Attention should remain focused on the safe operation of fuel distribution and the safety of people on the forecourt, not on the additional complexities and risks associated with alcohol sales. Given the existing health and safety responsibilities inherent in managing a fuel site, this added risk is both unnecessary and inappropriate.

For these reasons, I strongly urge the Licensing Committee to refuse the alcohol license application for Bowling Green Service Station in the interests of community safety, crime prevention, and public wellbeing.
