The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012

In order to comply with the statutory requirements, a Member must register disclosable pecuniary interests with the Town Clerk of the Morecambe Town Council within 28 days of the date of election, and, in respect of an interest that is not already registered, within 28 days of disclosing that interest at a meeting of the council. It is a criminal offence knowingly or recklessly to provide information that is false or misleading.

In this form, the following definitions apply:

“body in which the relevant person has a beneficial interest” means a firm in which the relevant person is a partner or a body corporate of which the relevant person is a director, or in the securities of which the relevant person has a beneficial interest;

“director” includes a member of the committee of management of an industrial and provident society;

“land” excludes an easement, servitude, interest or right in or over land which does not carry with it a right for the relevant person (alone or jointly with another) to occupy the land or to receive income;

“relevant authority” means the Council of which you are a member;

“relevant period” means the period of 12 months ending with the day on which you notify a disclosable pecuniary interest;

“relevant person” means you or your spouse or civil partner, a person with whom you are living as husband and wife, or a person with whom you are living as if you are civil partners;

“securities” means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.
